I. Chairman's Remarks -

- a) Approval of Board Minutes from January Kelly King moved to approve, Gordon Johnson seconded the motion. All were in favor and unanimously approved.
- b) Performance All green measures. All above average. CMA's doing a great job.

II. President's Report

- a) COVID-19 Updates expect diminished performance results because of COVID-19. 90% of our staff working remotely. Continuing performance with supervisors checking in. Leadership meeting weekly to see if updates need to be made from plan. Original plan was 2 to 4 weeks, may be longer. Plan updated as necessary.
- b) Zoom meetings with foster parents began this this morning and will have another this afternoon.
- c) COVID-19 has changed the way we contact parents/children. We can teleconference to see children.
- d) Schools closed with digital schooling. Marion County trying to provide Chrome Books, etc. as needed.
- e) With schools closed and people staying home, including over 120 daycares closed, there seems to be a decline in calls.
- f) Suspending visitations between siblings and parent/children. Trying to get clarification due to some courts may have different wording than Supreme Court.
- g) May see change in week or two. Case Managers will be considered essential employees if there is a shelter in place order.
- h) Courts each county working differently. Case hearings possibly using Zoom/video conferencing.
- i) Mark's YFA update visits, if not in person, are done by video conferencing. High risk cases are being evaluated as needed.
- a) Legislative Session Updates Several bills passed.
 - a. 1324 Jordan's Law, 1326 DCF Accountability Act
